## **Nomination information**

The nomination must nominate one (1) candidate only, state the candidate's full name and be signed by the candidate and at least three (3) other veterinary surgeons registered in Queensland. Nominations must be received by the Returning Officer by 5.00 pm on Wednesday, 26 August 2020. To enable verification of the three (3) other veterinary surgeons, their names and registration numbers should be printed after their signature.

The nomination may be accompanied by the candidate's written statement of not more than 200 words. If more than two (2) candidates are nominated, a ballot will be conducted, and the candidates' statements will accompany the ballot papers forwarded to all veterinary surgeons.

## **Board members' remuneration and commitments**

The membership of the Board includes 2 members elected by veterinary surgeons registered in Queensland.

Prospective candidates are advised that members of the Veterinary Surgeons Board receive remuneration in accordance with Cabinet-approved rates which apply to the whole-of-Government. The maximum meeting fee is currently \$400 and the special assignment fee (e.g. premises inspections) is \$200. Members are paid all necessary and reasonable expenses incurred while travelling on approved business and to attend meetings.

Board members commitments include, but are not limited to, attendance at day time meetings in Brisbane each month with prior study of agenda papers, regular telephone and email communications between meetings, special assignments including undertaking inspections of premises intended for use as veterinary premises and conducting interviews as required, and representing the Board on various committees of the profession, industry and government and at seminars, meetings and forums.

The Board is reliant on the elected members to have extensive experience and knowledge in clinical practice. The elected members must be prepared to evaluate the performance of clinicians against modern day veterinary standards in an unbiased and well-informed manner.

The *Veterinary Surgeons Act 1936* acts in the public interest as a means to ensure domestic and international consumer protection and animal welfare in the delivery of veterinary services. Only veterinary surgeons genuinely supportive of this purpose should nominate for election to the Board.
